Kim Collins, Human Resources Manager for St. Clair CPA Solutions, said that about 20 employees from the company's two offices in Conshohocken, PA and Merchantville, NJ contributed their time to help prepare the meal, while other employees made a financial contribution in support of the dinner and PRMH.

Employees who could not be in the PRMH kitchen on Friday afternoon and evening helped in preparation prior to the event by shopping and baking. A dozen employees arrived at PRMH at 2:30 pm on June 25<sup>th</sup> to cook, serve, and clean up after the dinner, which included eggplant parmigiana, chicken parmigiana, vegetables, salad, and dessert for approximately 80 people.

Linda Parry, PRMH Director of Volunteers, said that the nonprofit "home-away-from-home" for families with critically ill children in treatment at area hospitals relies on volunteer contributions to prepare and serve meals to its guests. "When families come back to PRMH from a long day at the hospital, it's a relief to be able to sit down to a home-cooked meal," said Parry.
